INSTRUCTIONS FOR PAPERWORK CIK-FIA Race in BAHREIN on Nov. 20-23rd 2013

TO ALL THE TEAMS,

Pls note that for going to BAHREIN, we will need you to do "Temporary Exportation", as Bahrein does Not belong to the CARNET ATA chain .

Here the Information which needs to be provided by every Team:

- Proforma Invoice detailed as much as possible for you with Serial Numbers of the Kart and Engines where available
- **Packinglist**

TO BE PUT AT THE END OF THE PROFORMA INVOICE:

Goods not for SALE, no commercial value Goods only to be used at the CIK-FIA Karting Championship from 19th to 23rd November 2013 After the Event , the goods will be Re-Exported to their Origin Country .

TEMPORARY EXPORTATION:

For the Temporary Exportion , you need to go to Your Respective Customs House from your Region where you are coming from and present the Profoma Invoice i/o to obtain the Temporary Exportation Document .

After Checking all the Documents , Customs will tell you if you will need to Present them the Cargo or not , or if some Pictures will be enough , but same Decision always belongs to the Customs Officer in Charge of the Exportation .

For the Customs your need to tell them that the Port of Exit from Europe will "Napoli Port".

TIMEFRAME:

In General the Timeframe to obtain such a Declaration , takes about 10-15 days .

To be on SAFE Side , I would suggest you to be ready with the Proforma Invoice on $Friday\ 13^{th}\ SEPTEMBER$, so in case any troubles or extra questions from Customs You have some Spare Time .

HANDING OVER FROM THE DOCUMENTS:

Every Team will need to hand me over their Documentation in Sarno :

- 3 x Original Proforma Invoices / Stamped and Signed in Blue Ink
- 3 x Original Packinlists
- Customs Declaration

Pls send me the The Proforma Invoices Upfront in Excel or Word Format, in case anything needs to be changed or modified for the Bahrein Customs.
